## Privacy Notice for Employment Applicants Residing in California

This Privacy Notice ("Privacy Notice") supplements the information in the TDK Corporation Global Privacy Policy (available at <u>https://www.tdk.com/corp/en/policy/index.htm</u>) and applies solely to current and former applicants for employment by TLA who reside in the State of California. TLA has adopted this Privacy Notice to comply with the California Privacy Rights Act (the "CPRA"). Any terms defined in the CPRA have the same meaning in this Privacy Notice.

### PERSONAL INFORMATION WE COLLECT

When Viewing Job Listings In Our Career Center: We do not require that you create a login ID or provide Personal Information in order to review job listings in our Career Center. We may collect information such as usage and interaction data, IP addresses, online identifiers, and cookies from our online career sites and applications.

**When Applying For A Job Opening:** When you apply for a job at TLA, we may collect the following information:

- Contact information (name, phone, address, email)
- Educational background, degrees, and certifications
- Professional experience and qualifications
- Professional references
- Compensation expectations
- Job openings of interest
- Source of information concerning job openings
- Gender, race, and ethnicity information
- Birthplace and national origin
- Work authorization status and sponsorship information
- Veteran status
- Medical and health information, disabilities, and necessary accommodations
- Location data
- Willingness to travel or relocate
- Background check information from service providers upon which offers may be contingent
- Banking information
- Information from third parties such as recruiters, employment agencies, online networks, and other vendors
- Usage and interaction data, account credentials, IP addresses, online identifiers, and cookies from online sites and applications of TLA and its service providers
- Inferences reflecting an applicant's preferences, characteristics, psychological trends, predispositions, behavior, attitudes, aptitude, and abilities

# HOW WE USE THIS PERSONAL INFORMATION

TLA may use the information it collects about its applicants for one or more of the following purposes:

- Preparation for interviews and hiring decisions

**Affiliates:** We may disclose personal information to affiliates of TLA to allow them to consider you for employment or other services, or as otherwise permitted by this Privacy Notice or application law or regulation.

In the preceding twelve (12) months, TLA has not sold any Personal Information of its applicants. If, in the future, TLA anticipates selling such Personal Information, we will provide you with all rights required by the CPRA.
